Requirements: User must be assigned "Iso. Applicant" permissions in PermitMe.

Getting Started:

This "Iso. Applicant" permission needs to be applied for using the following email link ToddEnergyPTW@toddenergy.co.nz.

The "Iso. Applicant" permission does not require a specific competency.

If you are a contractor to Todd Energy and require access to generate permits and isolations for task associated with Todd Energy facilities, reach out to us at ToddEnergyPTW@toddenergy.co.nz and we will provide you with a direct link to access PermitMe / IsolateMe.

Some Important User Information about the IsolateMe process:

- All isolations regardless of type start as a new request.
- All PermitMe users can add a request for an isolation to the PermitMe Isolation register.
- The Isolation Register is reviewed regularly by the facility support team who will allocate the request to a suitability competent isolation compiler to create an Isolation.
- The Isolation request number is the same as the new Isolation certificate number and once the request has been submitted can be added to the PermitMe permit for tracking.
- Where a User has non-complex competency in PermitMe they will be able to continue beyond the request stage to create the IC.
- These steps are contained within a separate PermitMe Job Aid: Create a Non-complex isolation certificate.









Fill out all the fields on the form.

On completion there is a button on bottom right of form that will show as

"Details Missing- click to validate form


Select

Requestor can edit request details by selecting:


"Edit Request Details" button.
